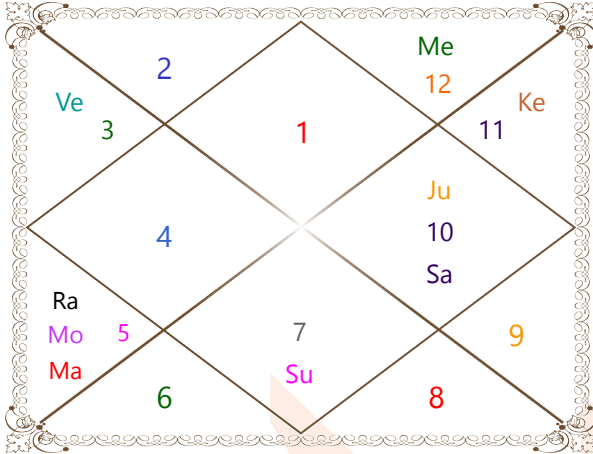
# ShodashVarga Charts

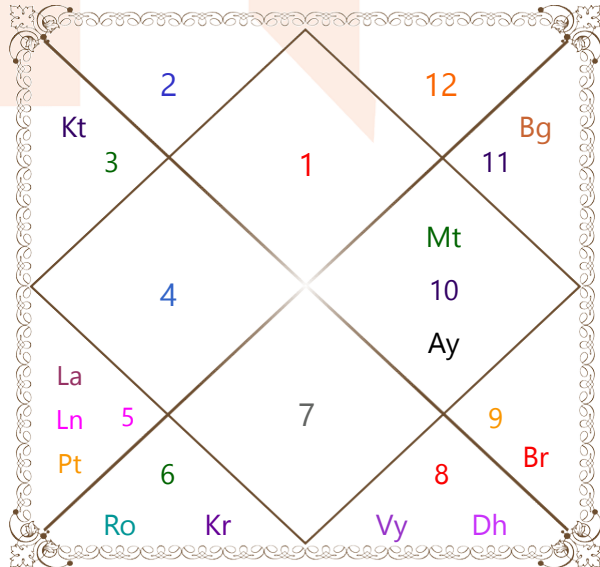

# Gem Selection

Gems are advised to increase the benefic effects in a natives life. Scientifically, Gems are capable of collecting the cosmic rays of the planet concerned and pass on to one's body to enhance the effect of that planet. That is why, we only recommend Gem for a planet benefic to the horoscope. A planet is benefic if it is placed or is lord of Lagna, Trikona or Kendra and is malefic if it is lord of 6, 8, 12 houses. It is benefic if it is placed with or aspected by friends. It is considered malefic if it is lord of Badhak house that is 11th lord for moveable, 9th lord for fixed and 7th lord for mixed ascendants. Above considerations define the goodness of the planets for Gem Selection.

Table below describes the area of work and benefic factor of the planet is percentage along with graphical display. Power of different Gems in different dashas is given in the other table. It is suggested to wear Gems throughout life without bothering for dasha or transits of the planets obtains over 75% marks. For those who secure 50-75% marks, it is suggested to wear gems in dasha of friendly planet or it is required to enhance the requisite area of concern. Gems for planets which obtain less than 50% should be normally ignored unless it obtains more than 50% marks in particular dasha.

## Detailed Analysis of Gems

**Aushadhi-mani-mantranam, graha-nakshatra tarikaah.  
Bhagyakale bhavetsiddhih abhagyām nishphalam bhavet. .**

Medicine, gems, and mantras are effective in overcoming diseases caused by planets and stars. If the time is favorable, the expected results are obtained; otherwise, all these remedial measures prove useless.

A gem enhances the physical charm of the wearer, increases power, and reduces the malefic influence of a planet with its mysterious powers. The flow of radiation emitted by planets in our body is enhanced by the power of gems. Therefore, planets that are auspicious in a horoscope but lack strength can be strengthened by wearing gems. Conversely, the gems of inauspicious planets multiply the malefic effects of such planets. This is why astrologers advise completely relinquishing the gems of inauspicious planets in a horoscope.

A planet is considered favorable when posited in the Lagna, Trikona, or Kendra, or if it has the lordship of these houses. It is inauspicious if connected to a Trik Bhava. The conjunction and aspect of friendly planets also enhance its auspiciousness. The lordship of a Badhak Bhava reduces its beneficence. In movable Lagnas, the 11th house; in stationary Lagnas, the 9th; and in dual Lagnas, the 7th house is termed a Badhak Bhava. The placement of planets in their enemy sign or sign of debilitation also decreases their auspiciousness.

For any horoscope, the gem of the Lagna lord is known as the 'life stone.' By wearing it, the wearer attains good results such as improved health, personality development, and an enhanced reputation. The gem of the 9th house lord is termed the 'lucky stone'; by wearing it, the development of destiny and an enhancement of status can be expected. Similarly, the gem of a Yoga Karaka planet is the 'Karak gem,' which has enough potential to provide financial gains, progress in tasks, and all-around development.

To gratify various desires, one might need to wear more than one gem. Detailed information about which gem would yield specific results in your horoscope is provided below. In addition, the method of wearing them is given along with the names of other gems that can be worn simultaneously. You can achieve maximum success in life with the right selection of gems.

A clear gem with a clean cut can absorb more radiation; therefore, only high-quality gems are capable of giving completely beneficial results. The weight of the gem should be in proportion to the weakness of the planet and the wearer's body weight. If the planet is very weak, the gem should be heavier. Except for diamonds, all gems should touch the skin. Gems worn on fingers in specific metals prove most beneficial.

If, for some reason, you need to remove the gem, it should be placed in a safe location after being washed with Gangajal on its designated day. If a gem is misplaced or stolen, it is an indication of the removal of the planet's malefic influence. Similarly, if the gem loses its luster, it indicates the same. Desired benefits are obtained by wearing the gem of an auspicious planet and through Jal Visarjan or the donation of articles and grains associated with inauspicious planets.

The Coral gem is your life stone; wearing it will ensure your health remains excellent. It will enhance your confidence and reputation, alongside progress on the professional front.

The Ruby or Pearl gem is your Karaka Ratna. By wearing it, you can expect growth on the professional front. You will earn financial gains, wealth, and property, along with an inflow of new energy into your life.

Therefore, you must wear the above-mentioned gems throughout your life. By wearing all these gems, the beneficence of all planets and all types of comforts can be expected. All the above-mentioned gems can be worn without considering or analyzing any Dasha and transit, as all of them are highly auspicious.

### **Ruby**

Avoid wearing Blue Sapphire and Gomed alongside Ruby. If you find wearing

these gems absolutely necessary, wear them in a locket or on the other hand. If you are unable to wear Ruby, you can wear Red Tourmaline, Pink Agate, Garnet, or a one-faced Rudraksha.

### **Pearl**

Avoid wearing Ruby, Coral, and Pearl along with Hessonite. If you find wearing these gems absolutely necessary, then wear them in a locket, rosary, or bracelet, or on the other hand. If you are unable to wear Hessonite, you can wear its substitute gems or an eight-faced Rudraksha.

### **Blue-Sapphire**

## Favourable Stone

Your favorable gemstone: Garnet.

Mars is considered a very important planet in astrology because he is next in order from the Moon, who is very near to the Earth. A man gets full cooperation and support from his younger brother after wearing this stone. Mars signifies younger brothers and physical strength. Wearing Garnet can also help in the cure of blood-related diseases such as high or low blood pressure, blood infections, etc.

Wear the Garnet-studded ring on the ring finger of the right hand, as this finger signifies the Sun in palmistry, and the Sun is a friendly planet to Mars. This ring should be worn on a Tuesday, as Mars is the lord of this day. The ring should be worn on Tuesday morning, within one hour of sunrise during the Hora of Mars. Mantra of Mars - Om Ang Angarkaye Namah.

Donate wheat, copper, jaggery, and 1¼ meters of red cloth to achieve better results. Recite the Mangal Mantra 108 times daily after bathing. Visit a temple of Lord Hanuman and offer Prasad every Tuesday. This will be highly beneficial.

# Rudraksha

Rudraksha is a Sanskrit word. If we split this word into two, we get Rudra and Aksha. Rudra means Lord Shiva and Aksha means the tears (Aanshu) of Lord Shiva. According to Hindu mythology, the tears of Shiva fell on earth in the form of the Rudraksha tree. The Rudraksha tree belongs to the Elaeocarpaceae family and is as massive as the Banyan tree, with seeds covered by pulp and outer skin. After drying, the skin turns black and grooves appear on the surface running from the apex to the bottom, thereby demarcating clear areas called 'Mukhas' or faces. Rudrakshas are classified on the basis of the number of faces, which can range from one to twenty-one.

Sometimes Rudrakshas are found in pairs (twins) which are considered to be symbols of Lord Shiva and Goddess Parvati. They are known as Gauri Shankar Rudrakshas. Similarly, if three Rudrakshas are joined together, they are considered symbols of Shiva, Shakti, and Ganesha, or Brahma, Vishnu, and Mahesh. However, these types of Rudrakshas are very rarely available. Scriptures like the Rudraksha Jabalopanishad, Shiva Purana, Devi Purana, and Padma Purana extol the value of Rudraksha seeds.

In general, all deities are fond of Rudrakshas, but it is believed that they are the most favorite of Lord Shiva. Modern scientific research has yielded positive results regarding Rudraksha. It has been found that they possess electromagnetic properties which influence human physiology. Each type of Rudraksha has its own unique influence and properties. Rudraksha is worn to achieve beneficial results and is helpful in managing conditions like epilepsy, hypertension, high blood pressure, stress, whooping cough, and wounds. Wearing Rudraksha not only pleases Lord Shiva but also brings the blessings of Lord Vishnu, Durga, Ganesha, and the Navgrahas (nine planets); it reduces the aging process and brings peace and harmony to life.

In Hindi, Bengali, Sanskrit, Bhojpuri, Gujarati, and Punjabi, it is known by the name Rudraksha. In Tamil, Kannada, and Telugu, it is known as 'Rudraksha Koti', in English as the Utrasum Bead, and in Latin as *Elaeocarpus ganitrus* Roxb. Rudrakshas can be found in India, Nepal, Tibet, Indonesia, Sumatra, China, Java, Malaysia, Madagascar, the Pacific Islands, etc. They are produced in Nepal in abundance. The one-faced Rudraksha is considered the property of the Royal family of Nepal and should be deposited in the national treasury. Anyone who dares to sell it shall be punished.

According to Hindu mythology, the Rudraksha of Nepal is the best in the world. The Goddess of wealth always resides in the house where Rudraksha is worshipped.

Rudraksha frees you from all sins committed knowingly or unknowingly. It fulfills your aspirations and prevents sudden death. It frees you from worries, satiates the wrath of the Gods, eliminates diseases, and brings auspiciousness. It grants mental peace and brings harmony to the home. It is auspicious for business, wealth, and prosperity, while also controlling one's temper and blood pressure. Wear Rudraksha for reputation, glory, and fame.

It enhances your willpower and memory. It is highly beneficial for high blood pressure, stomach disorders, and protection from negative spirits. Rudraksha can be worn by anyone irrespective of age, gender, or Rashi (Moon Sign). It frees you from problems and helps in the gain of progeny. Rudraksha never causes any negative impact; it is beneficial in every condition. A pregnant woman feels secure, protected, and is relieved of any fear after wearing it. Rudraksha fosters union in the family and enhances mutual love, affection, and respect. It enhances the attraction of one's personality. Rudraksha is the favorite ornament of Lord Shiva. The one-faced Rudraksha possesses all the aforementioned qualities.

Significance of Rudrakshas at a Glance:

1 Faced - Sun - Health, success, reputation, self-confidence, spirituality, happiness, sudden financial gains, personality development, victory over enemies; ideal for rulers, administrators, kings, and for attaining immense power.

2 Faced - Moon - Marital happiness, mental peace, contentment, good luck, concentration, spiritual progress, and harmony in the family and business; highly beneficial for women.

3 Faced - Mars - Victory over enemies and the removal of blood-related diseases.

4 Faced - Mercury - Education, knowledge, intelligence, spiritual discrimination, concentration, expression, and communication skills.

5 Faced - Jupiter - Physical, mental, and spiritual strength, as well as mental peace and happiness.

6 Faced - Venus - Love life, sexual vitality, attraction, strong memory, sharp intellect, accomplishment of tasks, and amazing success in business.

7 Faced - Saturn - Removes the malefic effects of Saturn; brings attainment of wealth, glory, victory, and success in business.

8 Faced - Rahu - Eliminates diseases, obstacles, and the malefic effects of Rahu; enhances knowledge and concentration; brings victory in legal issues, protection from accidents and enemies, success in business, and progress in life.

9-Faced - Ketu - Provides mental peace and success in business, protects from sudden death and the fear of accidents, and removes the malefic effects of Ketu.

10-Faced - Lord Mahaveer - Brings success in the professional sphere, enhances

stability, reputation, glory, and wealth, and ensures the fulfillment of material and spiritual desires.

11-Faced - Lord Indra - Brings financial gains and a prosperous life, ensures there is no deficiency of desired objects, and eradicates all troubles.

12-Faced - Lord Vishnu - Facilitates foreign travel, power, position, leadership qualities, and pleasure; removes physical and mental pain and brings all comforts and luxuries.

13-Faced - Lord Indra - Symbol of Cupid; beneficial for attraction, pleasure, the fulfillment of desires, and the attainment of glory, status, wealth, love, and beauty.

14-Faced - Saturn - Beneficial for spiritual progress, power, authority, glory, fame, and wealth; a symbol of Cupid.

### **Your Horoscope and Rudraksha**

Your grit and determination in accomplishing tasks will prove effective, though this dasha may not be very auspicious for your health. The 12th house represents expenses and is ruled by Pisces

It also favors long-term investments; however, this Jupiter may increase your expenses abroad. Generally, this type of Jupiter is not auspicious for financial matters.

Mercury in the 12th house indicates that you control your enemies very cleverly. You should avoid being lazy, as your harsh words could negatively affect your relationships with friends.

To achieve the auspicious results of all these planets, you should wear a Rudraksha Kavach consisting of 3, 4, 5-faced Rudrakshas. This Kavach should be worn on a white thread on Monday after sanctifying it by sprinkling Gangajal and chanting the "Om Namah Shivay" mantra at least 108 times. Afterward, offer raw milk to Lord Shiva and make donations according to your capacity. This will help you overcome difficult life situations and provide substantial relief from serious problems. To further strengthen all the planets in your horoscope, you may also wear a Shivkripa Rudraksha Mala comprising 1 to 14-faced Rudrakshas, which yields miraculous results.

The above Kavacham can be worn throughout life, regardless of Dasha and Gochar considerations. This Kavach is essential for overcoming the malefic effects of the Lagna and the planets placed within the Lagna.

## Sade-Sati Consideration

A horoscope is said to be under 'Sade-Sati' effect when the Saturn transits through the 12th, 1st and 2nd house from Natal Moon. It is said to be under 'Dhaiya' effect when Saturn transits over the 4th or 8th house over the Natal Moon. The effect of Sade-Sati remains for seven & a half year and that of Dhaiya remains for two and a half year. This generally affects health, mental peace & finance.

Generally Sade-Sati comes thrice in a horoscope in the life time - first in childhood, second in youth & third in old-age. First Sade-Sati has effect on education & parents. Second Sade-Sati has effect on profession, finance & family. The last one affects health more than anything else. Following tables give the periods of Sade-Sati and their effects.

## Remedies of Sade-Sati

Ill effect of Saturn's sade-sati can be reduced by giving alms, performing pooja, fasting or reciting mantra.

Give alms of black cloth, Urad pulse (horse-bean), black mole, leather shoes, cereals or iron as per your capacity. Perform pooja of Lord Saturn on Saturdays. Keep fast on Saturdays. Restrict your food to Urad pulse, grams, gram flour, black mole, black salt and fruits. Recite or get it recited by a brahmin the following Mantra for 19000 times on a Saturday:-

### **Om Pram Preem Praum Sah Shanaishcharaya Namah.**

To get benefic effects of sade-sati on health, mental peace, family happiness, finance and profession you are suggested for Maha-mrityunjaya Japa. Get the following mantra chanted for 125000 times.

### **Om Tryambakam Yajamahe Sugandhim Pushtivardhanam Urvarukamiva Bandhanan-Mrityormukshiya Ma-Amritat.**

Optionally chant 108 times the following mantra everyday in the morning:-

### **Om Houm Joom Sah Om Bhur Bhuvah Svah Om.**

You are also suggested to wear an iron ring made of a horse-shoe or nail from a boat. Wear the iron ring on the middle finger of the right hand.

Wear this stone in waxing moon on Saturday in the evening half an hour before sun set. Pushya, Anuradha or Uttara Bhadrapad nakshatra on that day is preferred. Keep fast on Saturday.

Before wearing the ring, clean it in fresh milk and Ganga water, light an incense stick, perform pooja and recite the following mantra 108 times:-

### **Om Sham Shanaishcharaya Nama**

After wearing the ring give alms. This will reduce the ill effects of Saturn giving peace and prosperity.

# Manglik Vichar

In the boy's or the girl's horoscope, when Mars is in the ascendant, fourth house, seventh house, eighth house, or twelfth house, it is called Manglik dosh.

**Lagne vyaye cha patale jamitre chashtame kuje.  
Stree bhartuvinasham cha bharta cha stree vinashanam. .**

Manglik dosh is considered stronger when Mars is placed in the ascendant than when Mars is conjoined with the Moon in the ascendant. If, according to the Shastras, the Manglik dosh of both the boy and the girl is cancelled, they are guaranteed a happily married life. On the other hand, if this Manglik dosh is not cancelled, they are likely to face unnecessary problems and hurdles in life. Therefore, one must begin his married life after getting the horoscopes thoroughly matched. After getting the Manglik dosh properly cancelled, the native shall be bestowed with a peaceful and wealthy life.

# Kaal Sarp Yoga

**Agre Rahunardha Ketuh Sarve Madhyagatah Grahaah.  
Yogyam Kaalsarpakhyo Shighram Tam Tu Vinashaya.**

If all seven planets are situated between Rahu and Ketu, Kaal Sarp Yog is formed. Therefore, it is essential for such natives to arrange for remedies for Kaal Sarp Yog so that the auspicious planets in the horoscope can provide favorable results.

Depending on the position of Rahu in the 12 houses of the horoscope, there are 12 types of Kaal Sarp Yog. These are:

1. Anant, 2. Kulik, 3. Vasuki, 4. Shankhpal, 5. Padma, 6. Mahapadma, 7. Takshak, 8. Karkotak, 9. Shankhchud, 10. Ghaatak, 11. Vishdhar, 12. Sheshnag

Kaal Sarp Yog is of two types: Ascending and Descending. If all seven planets are positioned within Rahu's mouth, it is Ascending Kaal Sarp Yog. If all planets are situated behind Rahu, then Descending Kaal Sarp Yog is formed.

If all the houses situated between Rahu and Ketu contain planets, then Kaal Sarp Yog is fully effective. If the Sun or Moon is present with Rahu or Ketu, then this yoga becomes more intense. If Rahu, the Sun, and the Moon are all situated together, Grahan Kaal Sarp Yog is formed. This is 1,000 times more powerful. For such a native, it is essential to arrange for remedies and Shanti rituals for Kaal Sarp Yog.

If in a horoscope all seven planets are between Rahu and Ketu, but a few planets are partially outside the Rahu-Ketu axis, then Partial Kaal Sarp Yog is formed. Even if only one planet is outside the axis of Rahu and Ketu, Partial Kaal Sarp Yog is still formed.

## The Effects of Kaal Sarp Yog

A native with Kaal Sarp Yog may suffer from mental unrest, hurdles in the acquisition of wealth, barriers to having children, and continuous disputes in married life. Usually, the native experiences bad dreams, and various fears and worries persist. The native may not receive full rewards for their talents, and success in work is typically delayed. Sudden loss of money or prestige is an indication of this yoga. Additionally, the native may suffer from unexplained diseases that are not easily cured by medicine.

The prescribed remedies for Kaal Sarp Yog can provide relief from these problems. According to the horoscope, whenever the Mahadasha or Antardasha of Rahu or Ketu occurs, Kaal Sarp Yog becomes more effective. The transit of Rahu and Ketu over the natal Rahu, Ketu, or Moon also makes this yoga more influential. At such times, remedies or worship performed with devotion are highly beneficial. You can also light a mustard oil lamp for 43 days before a Kaal Sarp Yog Yantra to alleviate troubles and ensure

all-around development.

### **Kaal Sarp Yog in Your Horoscope**

In your horoscope, the Shankhchur Kaal Sarp Yog is present in a descending order. While descending Kaal Sarp Yog does not strictly fit the traditional definition, it still exerts some influence. Consequently, there may be hurdles in your life, and you may have to struggle to move forward. However, these obstacles will eventually be removed. You might face difficulties in your job or suffer from a demotion; termination cannot be ruled out. If you are in business, you may face continuous losses. Friends may try to deceive you repeatedly. You might lack the bliss of your parents' company and could suffer due to deceit by maternal uncles or a brother-in-law.

Due to Kaal Sarp Yog, you may face issues with the state and have differences with government officials. There is a possibility of imprisonment or punishment by law. This yoga can cause frequent illnesses leading to financial losses and instability. You may remain mentally disturbed from time to time. Your married and family life could be painful and unsettled, lacking peace and happiness. You may feel dissatisfied in your sexual life. Despite trying various trades, success may remain elusive, and you might maintain only a normal level of esteem.

If you are experiencing the disturbances mentioned above, perform the following remedies for relief:

1. Install a Kaal Sarp Dosha Removal Yantra in your home and worship it regularly.
2. Offer a coconut in flowing water, such as a river, on three auspicious occasions.
3. Offer coal into flowing water (such as a river) on three occasions during an auspicious time.
4. Donate masoor dal (red lentils) and money to a poor person on three occasions at an auspicious time.
5. Recite the Hanuman Chalisa every day.
6. Use red curtains, bedsheets, and pillows in the bedroom.
7. Worship the family deity.
8. Donate brown clothes, til (sesame seeds), blankets, and seven grains at night during auspicious occasions.
9. Arrange for the recitation of, or recite, the Ketu Mantra 17,000 times during Ketu's Mahadasha or Antardasha.
10. Boil pine, mustard seeds, and loban (benzoin) in water and take a bath with this water (only once).
11. Feed birds with barley for 1¼ months.

12. Remedies for Rahu and Ketu: Use a blue handkerchief, a blue watchstrap, a blue pen, and an iron ring.

Important: Please note that the worship for Kaal Sarp Yog is performed using wooden sandals only. Do not use sindoor, roli (red lead), etc.

Kaal Sarp Yog Pooja can be performed at the Kalahasti Shiva Temple near Tirupati Balaji or at any of the 12 Jyotirlingas, such as the Somnath Temple in Saurashtra, Gujarat; Trimbakeshwar in Nashik, Maharashtra; Ujjain; Bhimashankar; Nageshwar; Rameshwaram; etc.



# Pitridosha Vichar

## What is Pitridosha?

Our deceased ancestors are termed as Pitar or Pitri. Pitri is a class between us and God. If they are happy the man is able to live a decent and successful life but if they are dissatisfied because of some reason then the native becomes victim of various types of diseases and troubles.

Later these Pitri either get Mukti (Liberation from the bondage of birth and death) or else take birth on this earth again. If all the Pitri in a family have taken rebirth or attained Mukti then for some time there are no Pitri for that specific family. In this situation the native gets fortunes and misfortunes on the basis of his own horoscope. Therefore, all family members should serve the Pitri by Tarpan etc. till the time they are there in Pitriloka. If Pitri are contented then they grant all round prosperity to the native.

The reason of unhappiness of Pitris resulting into Pitridosha can be untimely death of an ancestor or the unfulfilment of the last wish of the ancestor else the infliction of curse of someone on the soul of the ancestor. These ancestors need food in spite of being in Pitri Yoni. If family people do not offer food by Karmas like Tarpan etc then they become distressed and troubled. Pitri experience various types of troubles till the time they are not propitiated by Karmas like Puja Paath, Pindadaan and Tarpan etc.

Pitri Dosh generally happens not because of own Karmas rather because of the Karmas of parents and ancestors. This Dosh exists in the horoscope since birth but karmas get created after birth therefore the reason of Pitridosh remains inexplicable and only its symptoms are visible. We do not get auspicious results for our deeds in spite of having favorable Dasha and transit. At home there remains tension, disease, lack of peace and scarcity of funds. There are no issues or else one gets mentally retarded children who face obstacles in their progress or marriage.

Therefore when we face such above mentioned troubles continuously without having any visible reason in the horoscope then in that situation we must do propitiation of Pitridosha till the situation does not turn favorable.

## Symptoms of Pitridosha

- \* Sudden death or accident in family.
- \* Suffering from hereditary diseases and long chronic illness.
- \* The birth of handicapped or unwanted child in the family.
- \* The disrespectful and torturous behavior of children in the family.
- \* Difficulty in conceiving or miscarriage.

- \* Difficulties in the marriage of some family member.
- \* Quarrels in the family on some issue.
- \* Never ending poverty in the family.
- \* Becoming victim of bad habits.
- \* The birth of female child again and again.
- \* Obstacles in education.
- \* Seeing snakes in dreams.
- \* Earn stigma of infamy for bad deeds.
- \* The grey hairs of the elders start turning yellowish or else they suffer from black cough.
- \* Ancestors of the family demand food or clothes in dream.

### **How to Recognize Pitris?**

- \* Chant 11th chapter of Srimadbhagavadgita daily. Your Pitris shall show their face to you in your dreams.
- \* At night wash your hands and feet and pray in your mind and request your Pitris to give their Darshana to you.
- \* If you are facing obstacles in the accomplishment of your task then remember your Pitris and request them for the success of your tasks. I will do Shantipaath for you. If your this type of request results into the accomplishment of your task then it shall imply that you need to do Pitri Shanti.

### **Remedies for Pitri Dosha**

- \* Do Tarpan and Pindadaan on Mrityu Tithi during Shraadh. Offer food, clothes and Dakshina to Brahmin.
- \* If Mrityutithi is not known then these above mentioned karmas should be done on Amavasya.
- \* Offer Pitribhoga on each Amavasya and especially on Somvati Amavasya. Burn dry Kandas (pieces) of cow dung and give oblation of Kheer. Sprinkle few water drops and do Namaskar to Pitris.
- \* Offer water to Sun at the time of sun rise and chant Gayatri Mantra.
- \* Offer water, flowers, milk, Gangajal and black Til on Peepal tree while praying your Pitris. Say sorry for your mistakes and seek their blessings.
- \* Offer jaggary and wheat to cow on Sunday.
- \* Collect equal amount of money say one, five or ten rupees from all blood relations i. e. grandfather, grandmother, father, uncle, brother, sister, aunt etc and donate that in a temple. As per Lalkitab one gets rid of Pitri Rina by doing this.
- \* Listening of Harivanshpuraan Katha & Japa of Gayatri Mantra is very popular for

the purpose of rectification of Pitri Dosha.

- \* Do Tripindi Shraadh or Nandi Shraadh in Gaya or Trayambkeshwar.
- \* Naraynabali Puja should be done.
- \* Do Pitri Gayatri Anushthan by chanting following Mantra-

**Om devatabhyah pitribhyashcha mahayogibhya eva cha.**

**Namah svahayai svadhayai nityameva namo namah.**

\* The above given mantra should be chanted while doing Pitri Dosh rectification remedies like Pindadaan, Gayashraadh and Pitribhogarpanam etc.

- \* Do Srimadbhagvadgeeta Paath.

### **Guidelines for Pitri Puja**

- \* Do not offer non-vegetarian food to Pitris.
- \* Avoid non-vegetarian food on the day of Pitri Puja.
- \* Do not use utensils made of steel, iron, plastic and glass. Use the utensils made of leaves and clay only.
- \* Do not blow bell while doing Pitri Puja.
- \* Do not create any hindrance in the Puja of that person who is following the process of Pitri Puja.
- \* Respect your elders.
- \* Godan (donation of cow) done for Pitris propitiate them.
- \* The place where drinking water is kept is known as Pitri Sthan (Place of Pitris) therefore it should be kept spotlessly neat and clean.
- \* For Pitri Karmas there are total 99 days in a year which include 12 Mrityu Tithi, 12 Amavasyas, 12 Purnima, 12 Sankranti, 12 vaidhriti Yogas, 24 Ekadashi and 15 days of Shraadh.

### **Pitri Dosha In Your Horoscope**

- \* The lord of the 5th House house is under the influence of Saturn.

In your horoscope, Pitridosha is formed due to Sun.

Since the Sun is the Karaka of Pitridosha in your horoscope, the sins committed by your father are the root cause of your Pitridosha. To rectify this Pitridosha, you are advised to perform Gayatri Jap, Suryopasna, and the Aditya Hridaya Stotram. Perform Hawan with the Samidha of Aak and offer jaggery and wheat to a cow on Sunday.

However, if you are not experiencing the problems mentioned in the 'Symptoms of Pitridosha', then despite the presence of Pitridosha in your chart, there is no need for any remedies. It is quite probable that your ancestors are pleased by your auspicious deeds or have attained Moksha and are no longer troubling you.

**Note:**

Tripindi Shraadh and Narayan Naagbali are the main remedies for Pitridosha. These are done primarily in Tryambakeshwar. In Tripindi Shraadh the symbolic small statues of ancestors are made and Mantras are chanted on these. Finally they are flown in running water like Asthi Visarjanam.

Narayan Naagbali is done with the objective of fulfillment of desires of ancestors for their Moksha. In this Shamshankriya is done for two days and Manglik Puja on third day. If there are obstacles in getting married or begetting children because of Pitridosha then they get eradicated after observing these remedial measures.

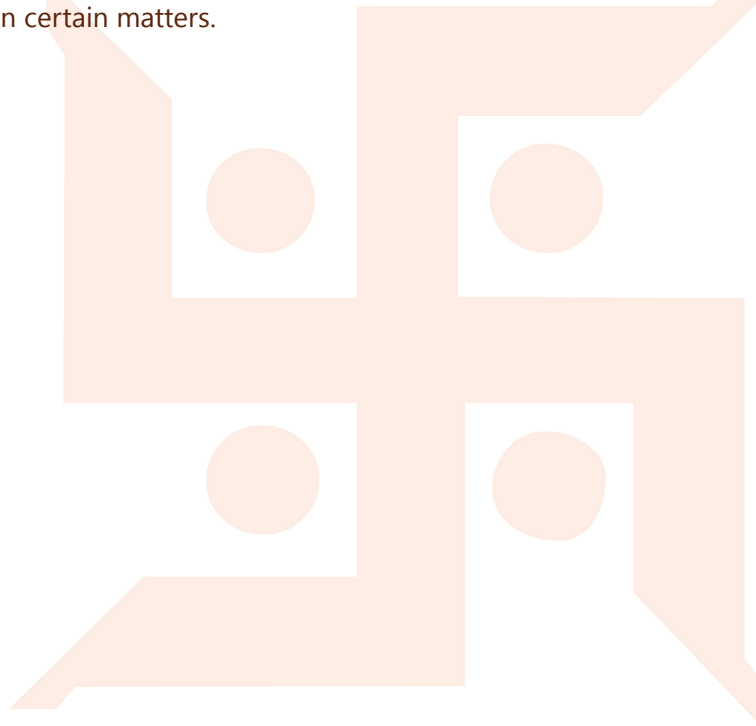
