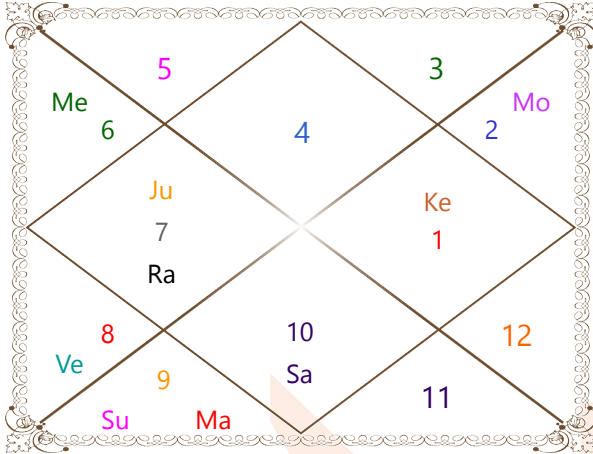
# ShodashVarga Charts

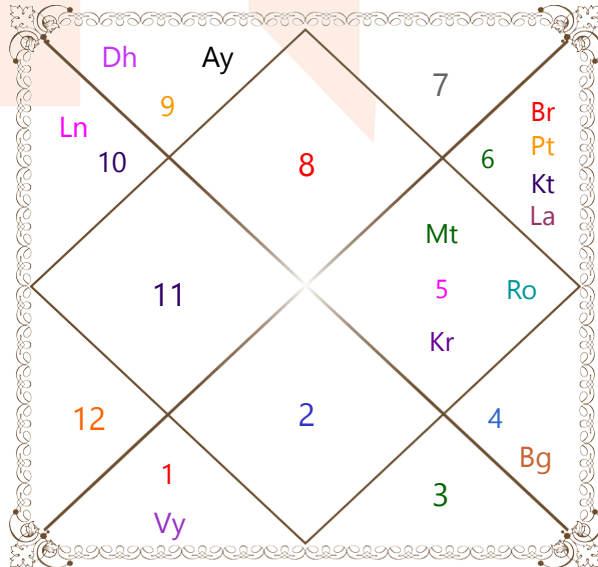

# Gem Selection

Gems are advised to increase the benefic effects in a natives life. Scientifically, Gems are capable of collecting the cosmic rays of the planet concerned and pass on to one's body to enhance the effect of that planet. That is why, we only recommend Gem for a planet benefic to the horoscope. A planet is benefic if it is placed or is lord of Lagna, Trikona or Kendra and is malefic if it is lord of 6, 8, 12 houses. It is benefic if it is placed with or aspected by friends. It is considered malefic if it is lord of Badhak house that is 11th lord for moveable, 9th lord for fixed and 7th lord for mixed ascendants. Above considerations define the goodness of the planets for Gem Selection.

Table below describes the area of work and benefic factor of the planet is percentage along with graphical display. Power of different Gems in different dashas is given in the other table. It is suggested to wear Gems throughout life without bothering for dasha or transits of the planets obtains over 75% marks. For those who secure 50-75% marks, it is suggested to wear gems in dasha of friendly planet or it is required to enhance the requisite area of concern. Gems for planets which obtain less than 50% should be normally ignored unless it obtains more than 50% marks in particular dasha.

## Detailed Analysis of Gems

### **Aushadhi-mani-mantranam, graha-nakshatra tarikaah. Bhagyakale bhavetsiddhiih abhagyām nishphalam bhavet. .**

Medicine, gems, and mantras are effective in overcoming diseases caused by planets and stars. If the time is favorable, the expected results are obtained; otherwise, all these remedial measures prove useless.

A gem enhances the physical charm of the wearer, increases power, and reduces the malefic influence of a planet with its mysterious powers. The flow of radiation emitted by planets in our body is enhanced by the power of gems. Therefore, planets that are auspicious in a horoscope but lack strength can be strengthened by wearing gems. Conversely, the gems of inauspicious planets multiply the malefic effects of such planets. This is why astrologers advise completely relinquishing the gems of inauspicious planets in a horoscope.

A planet is considered favorable when posited in the Lagna, Trikona, or Kendra, or if it has the lordship of these houses. It is inauspicious if connected to a Trik Bhava. The conjunction and aspect of friendly planets also enhance its auspiciousness. The lordship of a Badhak Bhava reduces its beneficence. In movable Lagnas, the 11th house; in stationary Lagnas, the 9th; and in dual Lagnas, the 7th house is termed a Badhak Bhava. The placement of planets in their enemy sign or sign of debilitation also decreases their auspiciousness.

For any horoscope, the gem of the Lagna lord is known as the 'life stone.' By wearing it, the wearer attains good results such as improved health, personality development, and an enhanced reputation. The gem of the 9th house lord is termed the 'lucky stone'; by wearing it, the development of destiny and an enhancement of status can be expected. Similarly, the gem of a Yoga Karaka planet is the 'Karak gem,' which has enough potential to provide financial gains, progress in tasks, and all-around development.

To gratify various desires, one might need to wear more than one gem. Detailed information about which gem would yield specific results in your horoscope is provided below. In addition, the method of wearing them is given along with the names of other gems that can be worn simultaneously. You can achieve maximum success in life with the right selection of gems.

A clear gem with a clean cut can absorb more radiation; therefore, only high-quality gems are capable of giving completely beneficial results. The weight of the gem should be in proportion to the weakness of the planet and the wearer's body weight. If the planet is very weak, the gem should be heavier. Except for diamonds, all gems should touch the skin. Gems worn on fingers in specific metals prove most beneficial.

If, for some reason, you need to remove the gem, it should be placed in a safe location after being washed with Gangajal on its designated day. If a gem is misplaced or stolen, it is an indication of the removal of the planet's malefic influence. Similarly, if the gem loses its luster, it indicates the same. Avoid wearing Blue Sapphire and Gomed alongside Pearl. If you find wearing these gems absolutely necessary, wear them in a locket, rosary, bracelet, or on the other hand. If you are unable to wear Pearl, you can wear White Moonstone, White Agate, or a two-faced Rudraksha.

## Blue-Sapphire

Avoid wearing Ruby, Coral, and Yellow Sapphire alongside Blue Sapphire. If you find wearing these gems absolutely necessary, wear them in a locket, rosary, bracelet, or on the other hand. If you are unable to wear Blue Sapphire, you can wear Turquoise, Amethyst, Neeli, or a seven-faced Rudraksha.

Avoid wearing Diamond and Gomed alongside Yellow Sapphire. If you find wearing these gems absolutely necessary, wear them in a locket, rosary, bracelet, or on the other hand. If you are unable to wear Yellow Sapphire, you can wear Topaz, yellow agate, yellow stone (Pitambari), or a five-faced Rudraksha.

## Cat's eye

## Favourable Stone

Your favorable gemstone: Moonstone

Your ascendant is Scorpio, and the lord of this sign is Mars. A moonstone is worn for the planet Moon. The Moon is the lord of the house of luck for those born with a Scorpio ascendant. Good fortune is a primary requirement in the life of the native. If fortune favors him, he receives the full results of his efforts, and his name and fame increase.

Therefore, it is very beneficial for those born with a Scorpio ascendant to strengthen their natal Moon. The Moon can be strengthened by worshipping it in the prescribed way and by reciting the proper mantra. A moonstone is recommended for the Moon.

When a person born with a Scorpio ascendant or Rashi wears a moonstone studded in a ring, he attains happiness, prosperity, and success in life. His fortune will shine, and he will achieve success and prosperity. The Moon also signifies ministerial positions; thus, by wearing a moonstone, one can gain fame and recognition in his field of activity and receive full support from his superiors and bosses.

The native also receives the full blessings of his mother after wearing this stone. The Moon signifies the mind and the mother of the native. Therefore, it can prove very beneficial for those suffering from any kind of mental disorder, including depression.

Wear the ring studded with a moonstone on the little finger of the right hand, as this finger signifies Mercury according to palmistry, and the Moon considers Mercury its friend. This ring should be worn on a Monday, as the Moon is the lord of this day. This ring should be worn during the first hora of Monday—that is, within one hour of sunrise—as the first hora of Monday is the hora of the Moon. If this stone is worn in the constellations of the Moon—Rohini, Hasta, or Shravana—falling on a Monday, it will be very beneficial.

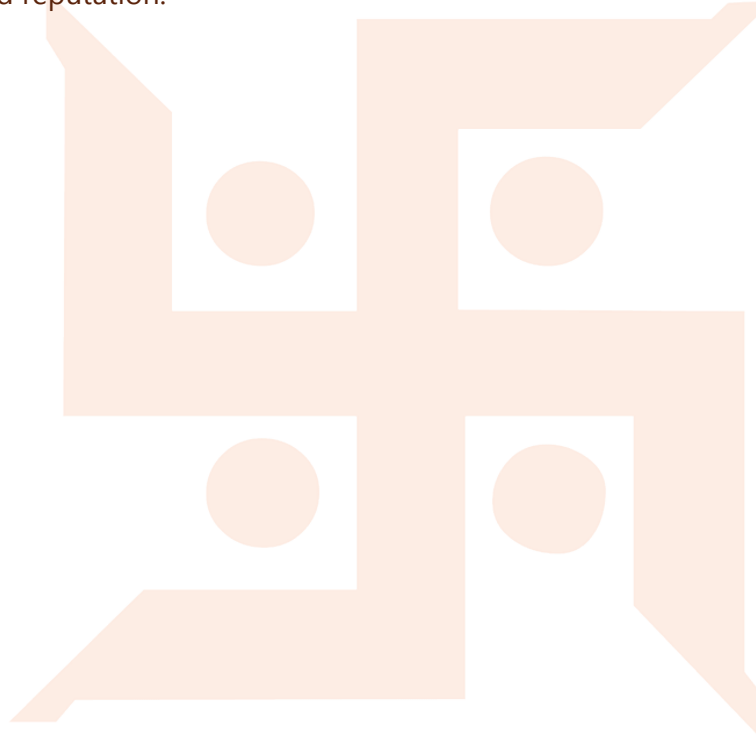
Clean the moonstone with Ganga water and a mixture of milk, curd, honey, clarified butter, and sugar. After this, place a white cloth on a wooden platform and keep the moonstone on it. Light incense sticks, a ghee lamp, and dhoop in front of it, and recite the Chandra Mantra 108 times to energize the moonstone. After this,

touch it to your forehead and wear it on the little finger of the right hand.

Mantra of the Moon - Om Som Somaye Namah.

Donate white rice, sugar, curd, and a 1¼-meter length of white cloth to get better results. Recite the Chandra Mantra 108 times daily after bathing. Offer water to the Shivalinga and worship Lord Shiva in the morning. Read the Shiv Chalisa on Mondays. This will also be very beneficial.

Men born under the Capricorn ascendant who wear Moonstone are blessed with favorable fortune, name, fame, power, position, and happiness. They lead a life of success and reputation.



# Rudraksha

Rudraksha is a Sanskrit word. If we split this word into two, we get Rudra and Aksha. Rudra means Lord Shiva and Aksha means the tears (Aanshu) of Lord Shiva. According to Hindu mythology, the tears of Shiva fell on earth in the form of the Rudraksha tree. The Rudraksha tree belongs to the Elaeocarpaceae family and is as massive as the Banyan tree, with seeds covered by pulp and outer skin. After drying, the skin turns black and grooves appear on the surface running from the apex to the bottom, thereby demarcating clear areas called 'Mukhas' or faces. Rudrakshas are classified on the basis of the number of faces, which can range from one to twenty-one.

Sometimes Rudrakshas are found in pairs (twins) which are considered to be symbols of Lord Shiva and Goddess Parvati. They are known as Gauri Shankar Rudrakshas. Similarly, if three Rudrakshas are joined together, they are considered symbols of Shiva, Shakti, and Ganesha, or Brahma, Vishnu, and Mahesh. However, these types of Rudrakshas are very rarely available. Scriptures like the Rudraksha Jabalopanishad, Shiva Purana, Devi Purana, and Padma Purana extol the value of Rudraksha seeds.

In general, all deities are fond of Rudrakshas, but it is believed that they are the most favorite of Lord Shiva. Modern scientific research has yielded positive results regarding Rudraksha. It has been found that they possess electromagnetic properties which influence human physiology. Each type of Rudraksha has its own unique influence and properties. Rudraksha is worn to achieve beneficial results and is helpful in managing conditions like epilepsy, hypertension, high blood pressure, stress, whooping cough, and wounds. Wearing Rudraksha not only pleases Lord Shiva but also brings the blessings of Lord Vishnu, Durga, Ganesha, and the Navgrahas (nine planets); it reduces the aging process and brings peace and harmony to life.

In Hindi, Bengali, Sanskrit, Bhojpuri, Gujarati, and Punjabi, it is known by the name Rudraksha. In Tamil, Kannada, and Telugu, it is known as 'Rudraksha Koti', in English as the Utrasum Bead, and in Latin as Elaeocarpus ganitrus Roxb. Rudrakshas can be found in India, Nepal, Tibet, Indonesia, Sumatra, China, Java, Malaysia, Madagascar, the Pacific Islands, etc. They are produced in Nepal in abundance. The one-faced Rudraksha is considered the property of the Royal family of Nepal and should be deposited in the national treasury. Anyone who dares to sell it shall be

punished.

According to Hindu mythology, the Rudraksha of Nepal is the best in the world. The Goddess of wealth always resides in the house where Rudraksha is worshipped. Rudraksha frees you from all sins committed knowingly or unknowingly. It fulfills your aspirations and prevents sudden death. It frees you from worries, satiates the wrath of the Gods, eliminates diseases, and brings auspiciousness. It grants mental peace and brings harmony to the home. It is auspicious for business, wealth, and prosperity, while also controlling one's temper and blood pressure. Wear Rudraksha for reputation, glory, and fame.

It enhances your willpower and memory. It is highly beneficial for high blood pressure, stomach disorders, and protection from negative spirits. Rudraksha can be worn by anyone irrespective of age, gender, or Rashi (Moon Sign). It frees you from problems and helps in the gain of progeny. Rudraksha never causes any negative impact; it is beneficial in every condition. A pregnant woman feels secure, protected, and is relieved of any fear after wearing it. Rudraksha fosters union in the family and enhances mutual love, affection, and respect. It enhances the attraction of one's personality. Rudraksha is the favorite ornament of Lord Shiva. The one-faced Rudraksha possesses all the aforementioned qualities.

Significance of Rudrakshas at a Glance:

1 Faced - Sun - Health, success, reputation, self-confidence, spirituality, happiness, sudden financial gains, personality development, victory over enemies; ideal for rulers, administrators, kings, and for attaining immense power.

2 Faced - Moon - Marital happiness, mental peace, contentment, good luck, concentration, spiritual progress, and harmony in the family and business; highly beneficial for women.

3 Faced - Mars - Victory over enemies and the removal of blood-related diseases.

4 Faced - Mercury - Education, knowledge, intelligence, spiritual discrimination, concentration, expression, and communication skills.

5 Faced - Jupiter - Physical, mental, and spiritual strength, as well as mental peace and happiness.

6 Faced - Venus - Love life, sexual vitality, attraction, strong memory, sharp intellect, accomplishment of tasks, and amazing success in business.

7 Faced - Saturn - Removes the malefic effects of Saturn; brings attainment of wealth, glory, victory, and success in business.

8 Faced - Rahu - Eliminates diseases, obstacles, and the malefic effects of

Rahu; enhances knowledge and concentration; brings victory in legal issues, protection from accidents and enemies, success in business, and progress in life.

9-Faced - Ketu - Provides mental peace and success in business, protects from sudden death and the fear of accidents, and removes the malefic effects of Ketu.

10-Faced - Lord Mahaveer - Brings success in the professional sphere, enhances stability, reputation, glory, and wealth, and ensures the fulfillment of material and spiritual desires.

11-Faced - Lord Indra - Brings financial gains and a prosperous life, ensures there is no deficiency of desired objects, and eradicates all troubles.

12-Faced - Lord Vishnu - Facilitates foreign travel, power, position, leadership qualities, and pleasure; removes physical and mental pain and brings all comforts and luxuries.

13-Faced - Lord Indra - Symbol of Cupid; beneficial for attraction, pleasure, the fulfillment of desires, and the attainment of glory, status, wealth, love, and beauty.

14-Faced - Saturn - Beneficial for spiritual progress, power, authority, glory, fame, and wealth; a symbol of Cupid.

It represents taxes, sleep, bed pleasures, confinement, foreign journeys, and salvation. The lord and any planets placed in the 12th house can increase the inauspiciousness of this house.

When Jupiter is in the 8th house, there may be a loss of paternal property. However, intelligence and spiritual discernment will help you earn money. Your destiny progresses with the help of your mother. While wealth may be average and you might face obstacles in your progress—with even the possibility of imprisonment not ruled out—this type of Jupiter creates challenges in the unfolding of your destiny. You will eventually succeed in accomplishing tasks and attaining wealth and reputation after significant struggle. You are likely to spend money on auspicious activities, and your mother, family, property, vehicle, and education will bring you happiness.

The placement of Rahu in the 8th house is not considered auspicious for family happiness. It can destroy inherited property and create unnecessary struggles and losses. This placement also increases anger, so you are advised to avoid useless discussions. At times, feeling neglected by family may lead to losses, humiliation, or occasional gains. You may feel compelled to stay away from your own people.

To achieve the auspicious results of all these planets, you should wear a Rudraksha Kavach consisting of 3, 4, 5, 6, 8-faced Rudrakshas. This Kavach should be worn on a white thread on Monday after sanctifying it by sprinkling Gangajal and chanting the "Om Namah Shivay" mantra at least 108 times. Afterward, offer raw milk to Lord Shiva and make donations according to your capacity. This will help you overcome difficult life situations and provide substantial relief from serious problems. To further strengthen all the planets in your horoscope, you may also wear

a Shivkripa Rudraksha Mala comprising 1 to 14-faced Rudrakshas, which yields miraculous results.

The above Kavacham can be worn throughout life, regardless of Dasha and Gochar considerations. This Kavach is essential for overcoming the malefic effects of the Lagna and the planets placed within the Lagna.



## Sade-Sati Consideration

A horoscope is said to be under 'Sade-Sati' effect when the Saturn transits through the 12th, 1st and 2nd house from Natal Moon. It is said to be under 'Dhaiya' effect when Saturn transits over the 4th or 8th house over the Natal Moon. The effect of Sade-Sati remains for seven & a half year and that of Dhaiya remains for two and a half year. This generally affects health, mental peace & finance.

Generally Sade-Sati comes thrice in a horoscope in the life time - first in childhood, second in youth & third in old-age. First Sade-Sati has effect on education & parents. Second Sade-Sati has effect on profession, finance & family. The last one affects health more than anything else. Following tables give the periods of Sade-Sati and their effects.

## Remedies of Sade-Sati

Ill effect of Saturn's sade-sati can be reduced by giving alms, performing pooja, fasting or reciting mantra.

Give alms of black cloth, Urad pulse (horse-bean), black mole, leather shoes, cereals or iron as per your capacity. Perform pooja of Lord Saturn on Saturdays. Keep fast on Saturdays. Restrict your food to Urad pulse, grams, gram flour, black mole, black salt and fruits. Recite or get it recited by a brahmin the following Mantra for 19000 times on a Saturday:-

### **Om Pram Preem Praum Sah Shanaishcharaya Namah.**

To get benefic effects of sade-sati on health, mental peace, family happiness, finance and profession you are suggested for Maha-mrityunjaya Japa. Get the following mantra chanted for 125000 times.

### **Om Tryambakam Yajamahe Sugandhim Pushtivardhanam Urvarukamiva Bandhanan-Mrityormukshiya Ma-Amritat.**

Optionally chant 108 times the following mantra everyday in the morning:-

### **Om Houm Joom Sah Om Bhur Bhuvah Svah Om.**

You are also suggested to wear an iron ring made of a horse-shoe or nail from a boat. Wear the iron ring on the middle finger of the right hand.

Wear this stone in waxing moon on Saturday in the evening half an hour before sun set. Pushya, Anuradha or Uttara Bhadrapad nakshatra on that day is preferred. Keep fast on Saturday.

Before wearing the ring, clean it in fresh milk and Ganga water, light an incense stick, perform pooja and recite the following mantra 108 times:-

### **Om Sham Shanaishcharaya Nama**

After wearing the ring give alms. This will reduce the ill effects of Saturn giving peace and prosperity.

## Manglik Vichar

In the boy's or the girl's horoscope, when Mars is in the ascendant, fourth house, seventh house, eighth house, or twelfth house, it is called Manglik dosh.

**Lagne vyaye cha patale jamitre chashtame kuje.  
Stree bhartuvinasham cha bharta cha stree vinashanam. .**

Manglik dosh is considered stronger when Mars is placed in the ascendant than when Mars is conjoined with the Moon in the ascendant. If, according to the Shastras, the Manglik dosh of both the boy and the girl is cancelled, they are guaranteed a happily married life. On the other hand, if this Manglik dosh is not cancelled, they are likely to face unnecessary problems and hurdles in life. Therefore, one must begin his married life after getting the horoscopes thoroughly matched. After getting the Manglik dosh properly cancelled, the native shall be bestowed with a peaceful and wealthy life.

# Kaal Sarp Yoga

**Agre Rahurardha Ketuh Sarve Madhyagatah Grahah.  
Yogoyam Kaalsarpakhyo Shighram Tam Tu Vinashaya.**

If all seven planets are situated between Rahu and Ketu, Kaal Sarp Yog is formed. Depending on the position of Rahu in the 12 houses of the horoscope, there are 12 types of Kaal Sarp Yog. These are:

1. Anant, 2. Kulik, 3. Vasuki, 4. Shankhpal, 5. Padma, 6. Mahapadma, 7. Takshak, 8. Karkotak, 9. Shankhchud, 10. Ghaatak, 11. Vishdhar, 12. Sheshnag

Kaal Sarp Yog is of two types: Ascending and Descending. If all seven planets are positioned within Rahu's mouth, it is Ascending Kaal Sarp Yog. If all planets are situated behind Rahu, then Descending Kaal Sarp Yog is formed.

A native with Kaal Sarp Yog may suffer from certain shortcomings in life and might not receive full rewards for their talents. Success in work is typically delayed. The native may also suffer from unexplained diseases that are difficult to cure with medicine. Propitiation of Kaal Sarp Dosh becomes necessary to lead a normal life.

## Kaal Sarp Yog in Your Horoscope

Your horoscope does not contain Kaal Sarp Yog. Therefore, you do not require a Shanti Pooja for Kaal Sarp Yog. You will lead a happy life.

# Pitridosha Vichar

## What is Pitridosha?

Our deceased ancestors are termed as Pitar or Pitri. Pitri is a class between us and God. If they are happy the man is able to live a decent and successful life but if they are dissatisfied because of some reason then the native becomes victim of various types of diseases and troubles.

Later these Pitri either get Mukti (Liberation from the bondage of birth and death) or else take birth on this earth again. If all the Pitri in a family have taken rebirth or attained Mukti then for some time there are no Pitri for that specific family. In this situation the native gets fortunes and misfortunes on the basis of his own horoscope. Therefore, all family members should serve the Pitri by Tarpan etc. till the time they are there in Pitriloka. If Pitri are contented then they grant all round prosperity to the native.

The reason of unhappiness of Pitris resulting into Pitridosha can be untimely death of an ancestor or the unfulfilment of the last wish of the ancestor else the infliction of curse of someone on the soul of the ancestor. These ancestors need food in spite of being in Pitri Yoni. If family people do not offer food by Karmas like Tarpan etc then they become distressed and troubled. Pitri experience various types of troubles till the time they are not propitiated by Karmas like Puja Paath, Pindadaan and Tarpan etc.

Pitri Dosha generally happens not because of own Karmas rather because of the Karmas of parents and ancestors. This Dosha exists in the horoscope since birth but karmas get created after birth therefore the reason of Pitridosh remains inexplicable and only its symptoms are visible. We do not get auspicious results for our deeds in spite of having favorable Dasha and transit. At home there remains tension, disease, lack of peace and scarcity of funds. There are no issues or else one gets mentally retarded children who face obstacles in their progress or marriage.

Therefore when we face such above mentioned troubles continuously without having any visible reason in the horoscope then in that situation we must do propitiation of Pitridosha till the situation does not turn favorable.

## Symptoms of Pitridosha

- \* Sudden death or accident in family.
- \* Suffering from hereditary diseases and long chronic illness.
- \* The birth of handicapped or unwanted child in the family.

- \* The disrespectful and torturous behavior of children in the family.
- \* Difficulty in conceiving or miscarriage.
- \* Difficulties in the marriage of some family member.
- \* Quarrels in the family on some issue.
- \* Never ending poverty in the family.
- \* Becoming victim of bad habits.
- \* The birth of female child again and again.
- \* Obstacles in education.
- \* Seeing snakes in dreams.
- \* Earn stigma of infamy for bad deeds.
- \* The grey hairs of the elders start turning yellowish or else they suffer from black cough.
- \* Ancestors of the family demand food or clothes in dream.

### **How to Recognize Pitris?**

- \* Chant 11th chapter of Srimadbhagavadgita daily. Your Pitris shall show their face to you in your dreams.
- \* At night wash your hands and feet and pray in your mind and request your Pitris to give their Darshana to you.
- \* If you are facing obstacles in the accomplishment of your task then remember your Pitris and request them for the success of your tasks. I will do Shantipaath for you. If your this type of request results into the accomplishment of your task then it shall imply that you need to do Pitri Shanti.

### **Remedies for Pitri Dosha**

- \* Do Tarpan and Pindadaan on Mrityu Tithi during Shraadh. Offer food, clothes and Dakshina to Brahmin.
- \* If Mrityutithi is not known then these above mentioned karmas should be done on Amavasya.
- \* Offer Pitribhoga on each Amavasya and especially on Somvati Amavasya. Burn dry Kandas (pieces) of cow dung and give oblation of Kheer. Sprinkle few water drops and do Namaskar to Pitris.
- \* Offer water to Sun at the time of sun rise and chant Gayatri Mantra.
- \* Offer water, flowers, milk, Gangajal and black Til on Peepal tree while praying your Pitris. Say sorry for your mistakes and seek their blessings.
- \* Offer jaggary and wheat to cow on Sunday.
- \* Collect equal amount of money say one, five or ten rupees from all blood relations i. e. grandfather, grandmother, father, uncle, brother, sister, aunt etc and

donate that in a temple. As per Lalkitab one gets rid of Pitri Rina by doing this.

\* Listening of Harivanshpuraan Katha & Japa of Gayatri Mantra is very popular for the purpose of rectification of Pitri Dosha.

\* Do Tripindi Shraadh or Nandi Shraadh in Gaya or Trayambkeshwar.

\* Naraynbali Puja should be done.

\* Do Pitri Gayatri Anushthaan by chanting following Mantra-

**Om devatabhyah pitribhyashcha mahayogibhya eva cha.  
Namah svahayai svadhayai nityameva namo namah.**

\* The above given mantra should be chanted while doing Pitri Dosh rectification remedies like Pindadaan, Gayashraadh and Pitribhogarpanam etc.

\* Do Srimadbhagvadgeeta Paath.

### **Guidelines for Pitri Puja**

\* Do not offer non-vegetarian food to Pitris.

\* Avoid non-vegetarian food on the day of Pitri Puja.

\* Do not use utensils made of steel, iron, plastic and glass. Use the utensils made of leaves and clay only.

\* Do not blow bell while doing Pitri Puja.

\* Do not create any hindrance in the Puja of that person who is following the process of Pitri Puja.

\* Respect your elders.

\* Godan (donation of cow) done for Pitris propitiate them.

\* The place where drinking water is kept is known as Pitri Sthan (Place of Pitris) therefore it should be kept spotlessly neat and clean.

\* For Pitri Karmas there are total 99 days in a year which include 12 Mrityu Tithi, 12 Amavasyas, 12 Purnima, 12 Sankranti, 12 vaidhriti Yogas, 24 Ekadashi and 15 days of Shraadh.

### **Pitri Dosha In Your Horoscope**

\* The lord of the 5th House house is under the influence of Rahu.

In your horoscope, Pitridosha is formed due to Jupiter.

In your horoscope, Jupiter is the Karaka of Pitridosha; therefore, the sins committed by your grandfather are the root cause of your Pitridosha. To rectify this Pitridosha, you are advised to donate something to learned people, elderly Brahmins, and your spouse. Donate books to a school.

However, if you are not experiencing the problems mentioned in the 'Symptoms of Pitridosha', then despite the presence of Pitridosha in your chart, there is no need for any remedies. **Note:**

Tripindi Shraadh and Narayan Naagbali are the main remedies for Pitridosha. These are done primarily in Tryambakeshwar. In Tripindi Shraadh the symbolic small statues of ancestors are made and Mantras are chanted on these. Finally they are flown in running water like Asthi Visarjanam.

Narayan Naagbali is done with the objective of fulfillment of desires of ancestors for their Moksha. In this Shamshankriya is done for two days and Manglik Puja on third day. If there are obstacles in getting married or begetting children because of Pitridosha then they get eradicated after observing these remedial measures.

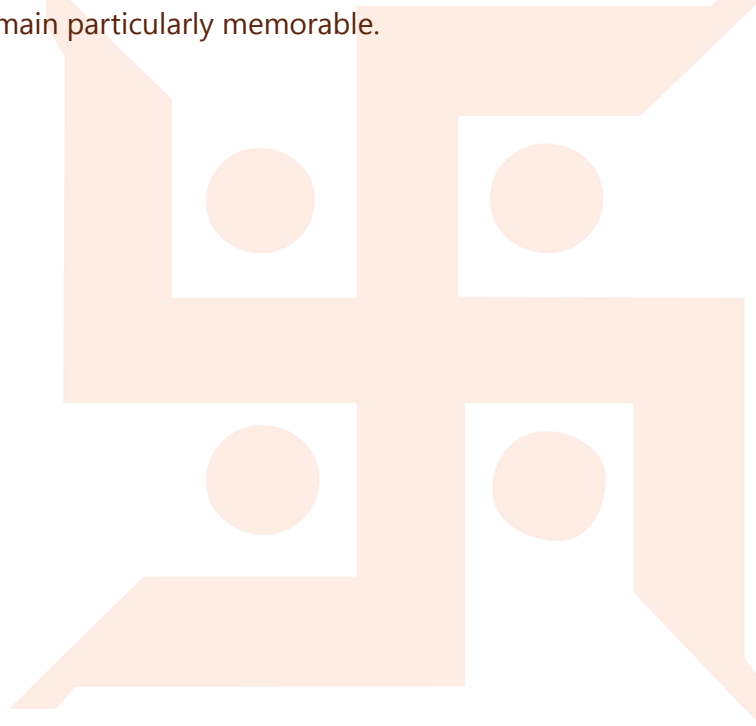

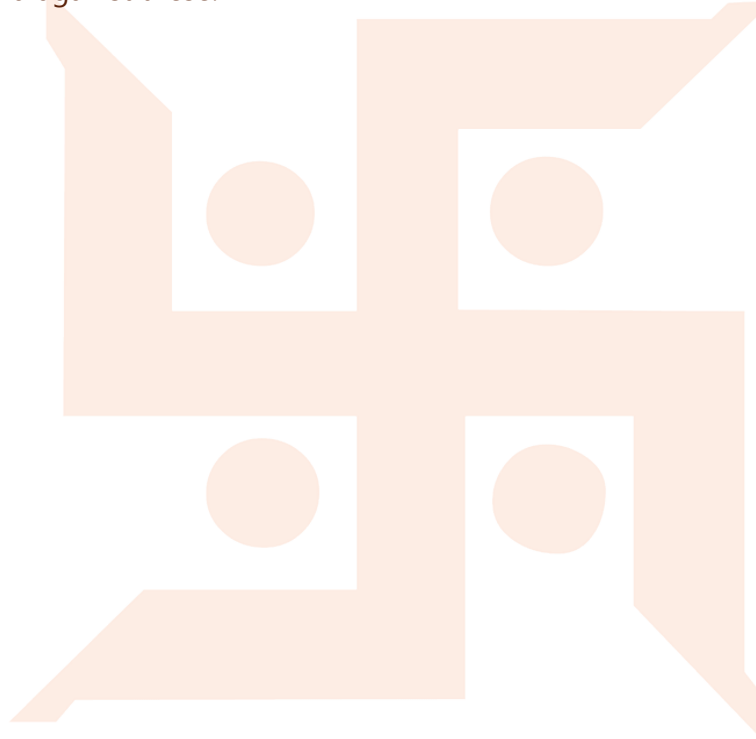

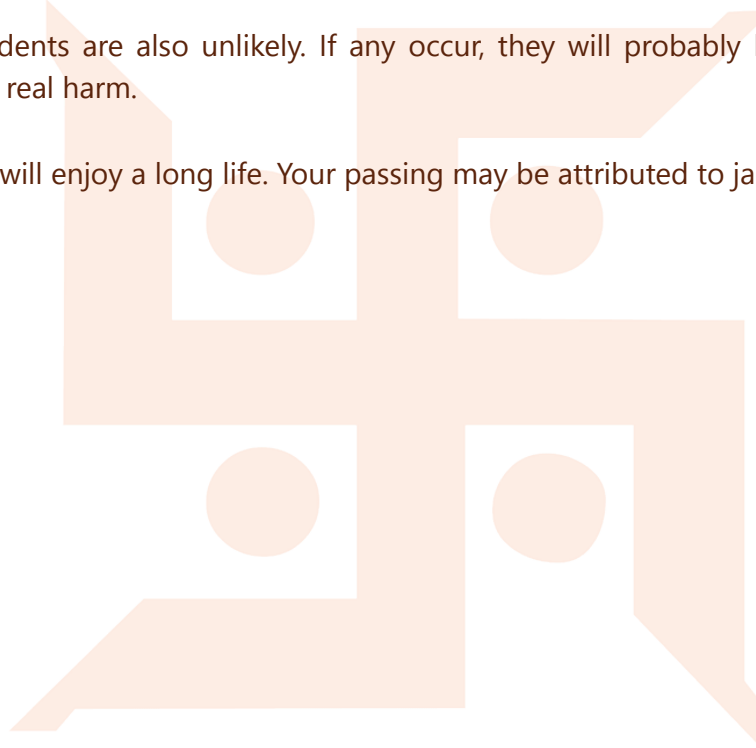
